DECREE Nº 56.347, 26th JANUARY 2022.

Provides for the adhesion of Rio Grande Sul to the "Race to Zero" and "Race to Resilience" campaigns, within the scope of the United Nations Framework Convention on Climate Change.

THE GOVERNOR OF RIO GRANDE DO SUL pursuant to the powers conferred on him by items II, V and VII of art. 82 of the State Constitution,

DECREES:

Article 1. - This Decree provides for the Rio Grande do Sul's adhesion to the "Race to Zero" and "Race to Resilience" campaigns, within the scope of the United Nations Framework Convention on Climate Change, in order to neutralizing net emissions of greenhouse effect by the year 2050 and to the climate resilience.

Article 2. - For the purposes of this Decree, the following actions will be implemented, under the coordination of the State Secretary of the Civil House and the State Secretary for Environment and Infrastructure:

I - preparation and approval of the State Plan on Climate Change 2050, as provided for in item VI of art. 9 of Law No. 13,594, of December 30th, 2010, within twelve months, which must include:

a) actions to neutralize net greenhouse gas emissions by the year 2050 and its intermediate targets;

b) actions for not granting new incentives, of any nature, to activities that make a significant contribution to greenhouse gas emissions, except those necessary to reduce these emissions and their adequacy;

c) regulation within the scope of the State Energy Planning Committee and the State Environment Council, as provided for in art. 17 of Law No. 15,434, of January 9, 2020, which provides for the reassessment and resizing of the State's energy matrix under the terms of art. 162 of the State Constitution, giving special emphasis to energy conservation strategies, increasing installed capacity in renewable energies, minimizing waste and reducing and controlling environmental pollution;

II - the preparation and approval, within twenty four months, of Sector Action Plans;

III - the installation, within three months, of the State Forum on Climate Change, mentioned in item II of art. 3 of Law No. 13,594, of December 30, 2010;

IV - the improvement, diversification of actions and the expansion, in up to twelve months, of the following conservation programs and projects and good practices in the use of natural resources developed within the State, in partnership with Class Federations, Universities, Municipalities, non-profit entities of the civil society and private sector entities:

a) expansion of the actions of the Hydrographic Basin Revitalization Program, in partnership with the Ministry of

Regional Development, Hydrographic Basin Management Committees and Companhia Riograndense de Saneamento - CORSAN, under the supervision of the State Council for Water Resources;

b) diversification of the actions of the Campos do Sul Program in order to conserving areas of the Pampa and Rainforest Biomes with the adoption of good environmental and management practices, in partnership with small rural producers and universities, under the coordination of the State Secretary for Environment and Infrastructure; and

c) expansion of the actions of the State Program for the Recovery of Native Vegetation in Rio Grande do Sul, in partnership with small rural producers, universities and other partner entities.

Article 3. - The State is committed to the following guidelines for the future, regardless of the elaboration of the State Plan on Climate Change 2050:

I - plan, develop and implement, in partnership with economic agents and universities, an Industrial Hub for the Production of Green Hydrogen and Green Ammonia, with the objective of making an energy transition in line with its production matrix and that is gradual, balanced and sustainable;

II - constantly update the Rural Environmental Registry - CAR, and the Environmental Regularization Programme - PRA;

III - promote studies to monitor the capture of greenhouse gases in the Pampa and Rainforest Biomes; and

IV - guarantee universal access for the population of the State, by the year 2033, to ninety-nine percent of treated water and ninety percent of treated sewage.

Article 4. - This Decree enters into force on the date of its publication.
